
## The Collington Capital Group

Collington Capital comprises three entities: a not-for-profit foundation, an impact advisory partnership, and a regulated impact investment bank. The group's purpose is to enable impact-led enterprises, including charities, not-for profits, and social enterprises, to access impact capital.

The firm works to achieve a vision of global capital markets providing flows of impact capital which transform the delivery of social impact at scale. Collington Capital aims to mobilise US\$500mn of catalytic philanthropic funding and investment capital over five years.

The Group comprises three entities:

- The Harriet Collington Foundation is a not-for-profit company facilitating the development and funding of blended finance impact investment solutions
- Collington Capital Partners LLP is an impact advisory partnership helping to integrate impact in the investment chain and build readiness for impact investment
- **Collington Capital Limited** is an authorised and regulated impact investment bank structuring impact investment solutions and raising impact investment.





The Harriet Collington Foundation (HCF) has been established to further the legacy of Harriet Collington, her sister Catherine Arnott, and successive generations of remarkable Collington women who were pioneers in their respective fields.

The foundation is a not-for-profit company facilitating the development and funding of blended finance impact investment solutions. It works with aligned and ambitious partners towards a vision of philanthropic funding catalysing flows of new impact investment to transform the delivery of social impact at scale in the UK and internationally. The foundation's medium-term goal is to mobilise US\$150mn of catalytic philanthropic funding over five years.

It will achieve this by using funding from donors, grantors and social investors to:

- deliver research, engagement and advocacy that helps philanthropic funders catalyse impact investment into impact-led enterprises
- develop blended finance solutions aligned with the goals of philanthropic funders leveraging grant funding to deliver social impact at scale
- provide grants and social investment for blended finance investment solutions that attract impact capital and help impact-led enterprises grow sustainably

HCF's focus is on the five impact goals most critical to addressing social inequality: poverty alleviation, better health, inclusive education, women's empowerment and economic development. HCF also addresses the inter-dependent threat of the climate crisis as it works with its partners to secure a socially just transition to a net zero world.

Olivia is a Founder Partner of Collington Capital and a Board Member and Chair of the Finance, Risk and Audit Committee of the Impact Investing Institute and, until recently, a Trustee Director and Chair of the Governance and Nominations Committee of ShareAction.

Previously Olivia led the Impact Investing Institute's work on impact management, measurement and reporting, and was a member of the G7 2021 Impact Taskforce and the 2017 Steering Group and then Taskforce on 'Creating a Culture of Social Impact Investing in the UK'.

In her early career, Olivia was a Managing Director of JP Morgan leading its European derivatives brokerage business and a Senior Adviser to the Financial Services Authority. Later Olivia served as a non-executive Director and member or Chair of many Board Committees, including for Virgin Money, Investec, Aon, Canada Life, Royal London and the Financial Reporting Council.
